# **CO-OP DEMOCRACY:** Nominees sought for director elections

It is once again time to nominate candidates for Tideland's annual director elections. The nominating committee will meet February 7, 2008, to consider candidates for directorial districts 2, 3, 7 and 10. Interested candidates should contact a member of the nominating committee prior to the meeting. The committee's nominees will be posted at all Tideland offices on February 8, 2008.

Nominations can also be made by submitting a petition signed by 15 co-op members no later than February 26, 2008.

## **DIRECTOR QUALIFICATIONS**

The following guidelines are excerpted from Board Policy No. 302 and Bylaw 4.02 to ensure quality representation.

## **Legal & Personal Requirements**

1. A Tideland member & bonafide resident of the directorial district.

- 2. A member no less than 2 years on the date of election.
- 3. Willing to promote & protect the co-op's interests.
- 4. Able to impartially represent the entire co-op membership.
- 5. Willing to regularly attend board meetings.
- 6. Can not be a close relative of an existing director or employee.
- 7. Is not employed by or financially interested in a competing enterprise.
- 8. Was not previously employed by TEMC, any other utility/energy company, or any entity which substantially rendered services to a utility/energy company.

## **Aspects of Service**

- 1. Put forth the effort to understand the co-op and provide sound judgement to reach decisions.
- 2. Respect official decisions made by a majority of the board.

## Dial 1-800-882-1001 To Pay Without Delay



One of the easiest ways to pay your electric bill is by phone. Before you get started please have your electric account number and debit or credit card handy.

Dial 1-800-882-1001. When the phone system answers say or press "4". Then say or enter your TEMC account number.

The system will tell you the date of your last payment and the amount currently due on your account.

To complete the transaction you will need to enter your credit card number, expiration date and zip code where the credit card bill is sent. When making payment you must pay the current or past due amount in its entirety. Partial payments can not be accepted using the phone system. To do so please press "0" for a customer service representative.

## Beware the **Window Dressing**

Auntie Em wants to save money and reduce drafts during cold winter nights. A nice young man from The Cure All Window Company, which she's seen advertised on TV, tells her she can save 50% on her energy bills by replacing all of her windows with low-e coated, argon-filled double-paned windows. They even have a sale going on: they will replace all 20 of her windows for \$200 each.

Her niece Dorothy, a graduate of the Building Science Department at Appalachian State University, doesn't think this is the best way for Auntie Em to save on her energy bill. Dorothy determines that 50% of Auntie Em's yearly energy use goes to heating and cooling her home. Auntie Em's energy bills total \$2,000 annually so \$1,000 of that is for heating and cooling. Typically, about 10% of the heating and cooling energy use is attributable to heat lost or gained through the windows. How long will it take Auntie Em to start saving money on her nice new windows?

Cost of Windows: 20 windows X \$200 = \$4,000Estimated Annual Heating and Cooling Costs: \$1,000 **Energy Lost Through Windows Annually: \$100** Annual Energy Savings From New Windows: \$50

Number of Years to Recoup Cost of Windows:

80 YEARS

Moral of the Story: There are lots of good reasons to replace windows but your energy improvement dollars are usually best invested elsewhere.
