

Hope is on the way

Eight Days of Hope (EDOH), a nonprofit faith-based organization formed shortly after Hurricane Katrina, has targeted Pamlico County for its annual labor of love. EDOH will bring together volunteers from across the nation to help rebuild homes in Pamlico County that were ravaged by Hurricane Irene.

Event organizers anticipate between 1,500 and 2,000 volunteer-laborers will make their way to eastern North Carolina between May 26 and June 2. The days start early with breakfast served at 6 a.m., and after morning fellowship, work crews will report for duty. Lunch is delivered to the job site and then its back to camp for a 6 p.m. dinner followed by evening fellowship.

Camp Seafarer in Arapahoe will serve as the primary camp site for volunteers who are asked to bring their own air mattresses or cots. Shower facilities and food will be provided.

EDOH continues to seek volunteers and the last day to submit a volunteer application is Saturday, May 19. Volunteers are asked to serve a minimum of three days.

Energy Star Homes: Savings from the ground up

Tideland has fielded a large number of phone calls from members regarding our new \$1,250 rebate for Energy Star homes. Here is an overview of the Energy Star home building process.

WHAT MAKES A HOME ENERGY STAR?

Homes that earn the Energy Star certification meet rigorous guidelines for energy efficiency typically making them 20-30% more efficient than standard homes. A third party, independent home rater is engaged to inspect and sign off on the Energy Star measures every step of the way to ensure the home meets program requirements.

Effective Insulation

When properly installed, it results in lower utility costs and a quieter, more comfortable home.

Tight Construction and Ducts

Help reduce drafts, moisture, dust, pollen, pests, and noise. A tightly sealed home improves comfort and indoor air quality while lowering utility and maintenance costs.

Efficient Heating and Cooling Equipment

When properly installed into a tightly sealed home, this equipment won't have to work so hard to heat and cool the home.

High Performance Windows

Energy-efficient windows employ advanced technologies to help keep heat in during the winter and out during the summer, also blocking damaging ultraviolet sunlight that can discolor carpets and furnishings.

Efficient Products

Energy Star qualified homes may also be equipped with Energy Star qualified products - lighting fixtures, compact fluorescent bulbs, ventilation fans and appliances, such as washing machines, refrigerators and dishwashers.



Third-Party Testing

A Home Energy Rating System (HERS) Rater conducts several on-site inspections to verify the energy efficiency measures including insulation, air sealing and duct sealing details. Testing

includes both blower door and duct blaster tests.

Energy Star homes deliver better protection against cold, heat, drafts, moisture, pests, pollution and noise. An energy-efficient home helps ensure consistent temperatures between rooms, improved indoor air quality and greater durability.

Compared with standard construction, Energy Star qualified homes use substantially less energy for heating, cooling and water heating. Additional savings on maintenance can also be significant.

To date, more than 3,500 builders have partnered with Energy Star and today there are over 1 million qualifying homes nationwide. By choosing to build an Energy Star home buyers can be confident that it will have an increasingly valued feature when it is time to sell the house.

Added Confidence

Energy Star certification makes it easy to identify homes that are truly energy efficient. Buyers can find the house of their dreams and enjoy peace of mind knowing it also meets rigorous energy efficiency guidelines set by the Environmental Protection Agency and verified by an independent Home Energy Rater.

HOW MUCH DOES IT COST TO BUILD AN ENERGY STAR HOME?

In North Carolina, it is estimated to cost approximately \$3,500 more to build an Energy Star home as opposed to minimum NC residential building code. That would increase your monthly mortgage by approximately \$18 which would be offset by monthly utility savings of more than \$30 per month. The \$1,250 Tideland rebate further enhances the member's rate of return.

Comparing Insulation VALUE

Adding insulation? Check the material's R-value—the ability of insulation to resist the transfer of heat. R-value depends on material, thickness, and density. A higher R-value indicates more effective insulation, saving energy dollars.

Compare R-values and common uses for several types of insulation:
