# **MEMBER MATH:** WPCA and capital credits exceed \$3.7 million in 2015

In keeping with our not-for-profit cooperative business principles, Tideland EMC issued credits to members and former members exceeding \$3.7 million in 2015.

Of that total, \$1.3 million was in the form of wholesale power cost adjustment (WPCA) credits that appeared on monthly power bills January through December.

The average monthly WPCA credit for 2015 was 0.385¢ per kilowatt hour (kWh) sold. In December 2015, the WPCA credit peaked for the year at 0.704¢ per kWh which translates into a credit of \$7.04 for every 1,000 kWh billed that month.

The December WPCA credit brought the billed rate per residential kWh down to 9.876¢, well below our published rate of 10.58¢. With unseasonably mild temperatures prevailing through December that month's kWh sales were down fifteen percent from December 2014. Therefore, we hope all members felt some payment relief as 2015 came to an end.

As was noted in last month's issue of Tideland Topics, the coop also approved a \$2.4 million capital credit general retirement refund in December.

The new year was off to a good start with a WPCA credit of \$6.64 per 1,000 kWh billed during January 2016. That kept the billed residential rate down to 9.916¢ per kWh as temperatures returned to more seasonable levels.

The US Energy Information Administration (EIA) reports that since July electricity generated from natural gas-fired power plants has exceeded generation from coal. Before April 2015, coal-fired generation had always outpaced natural gas. This

# Message to our Member-Owners: Community Solar

Tideland recently completed phase two of our community solar installation on Highway 32 in Pinetown. Combined, the two installations have a rated maximum output of 200 kW.

Originally the cooperative had planned to make solar subscriptions available to members that wanted to be active participants in renewable energy projects without incurring the substantial costs of installing residential solar. However, thanks to significantly reduced installation costs, which are inherent in larger ground installations compared to small, rooftop installations, we have decided to roll the solar production from the project into our own generating portfolio. While the power we produce at the site is not currently cheaper than traditional generating fuels like natural gas and nuclear, we believe in a few years' time the power costs associated with this installation will be within striking distance.

Therefore, we decided the entire membership would best be served by rolling the output into our own portfolio so all can benefit from our community solar project over the next 20 years. While our community solar project, which resides on just over one acre, is nowhere near the size of local solar farms, it is important for Tideland to remain innovative and diversify our energy resources to the greatest extent possible while remaining fiscally responsible to our members.


Along those same lines, we will soon kick off a pilot project in partnership with North Carolina Electric Membership Corporation to test the potential for incorporating microgrid strategies into our operational procedures. In its simplest terms, a microgrid is a smallscale power grid that can operate independently or in conjuction with an area's main electrical grid. Microgrids can be intended as back-up power during emergency situations or bolster the main power grid during periods of heavy demand and higher costs.

We look forward to bringing you more details about this exciting opportunity to study next generation utility strategies in the weeks and months ahead.

Nominations can also be made by submitting a petition signed by 50 co-op members no later than March 6, 2016. The last day to introduce new business via petition is April 25, 2016. The annual meeting of members will be held at Beaufort County Community College on Thursday, May 26, 2016.

#### **DIRECTOR QUALIFICATIONS**

The following guidelines are excerpted from Board Policy No. 302 and Bylaw 4.02 to ensure quality representation.

#### Legal & Personal Requirements

1. A Tideland member & bonafide resident of the directorial district.

2. A member no less than 2 years on the date of election.

3. Willing to promote & protect the co-op's interests.

4. Able to impartially represent the entire co-op membership.

5. Willing to regularly attend board meetings.
6. May not be a close relative of an existing director or employee.

7. Is not employed by or financially interested in a competing enterprise.

8. Was not previously employed by TEMC, any other utility/energy company, or any entity which substantially rendered services to a utility/energy company.

#### **Aspects of Service**

1. Put forth the effort to understand the co-op and provide sound judgement to reach decisions.

2. Respect official decisions made by a majority of the board.

3. Objectively evaluate questions and problems facing TEMC.

#### Points to Consider

1. Has the member demonstrated sound business judgement?

2. Has the member shown a capacity for leadership & a reputation for honesty & integrity?

3. Has the member shown a capacity for working well with others?

4. What problems might hinder the nominee's success?

increased use of natural gas for electricity generation primarily reflects sustained low prices for the fuel.

For the week ending January 4, 2016, natural gas spot market prices (Henry Hub) were \$2.39 per million Btu, a nearly 30% decline from January 2015 pricing. In November 2015 natural gas prices dipped to \$2.09/MMBtu, the lowest price since April 2012.

The EIA anticipates slightly warmer temperatures this winter east of the Rocky Mountains and in the South they forecast 8% fewer heating degree days. A warmer winter combined with favorable generating costs is expected to keep electricity expenditures down from last winter. In the South, 62% of all households use electricity as their primary space heating fuel.

All that being said, the real key to affordable energy bills is the wise and efficient use of electricity by employing smart thermostat strategies and good building envelope air sealing.
