


Member representation

No-cost energy management tools at your fingertips

On the heels of a fairly normal December, Tideland territory entered the New Year experiencing daily temperature lows in the 20s. The normal daily low for January is 34° The impacts of those temperature dips were immediately reflected in daily kilowatt hour consumption with even lower temperatures in the forecast for the second week of January.

Since September 2014, Tideland members have had access to "high energy use alerts." It's an amazing service option designed to prevent high bills yet we find many of you are still not utilizing it.

The easiest way to activate the service is to log on to the member portal by going to **tidelandemc.com** and clicking the "Member Portal" link.

Once you've logged in, click on "My Account" and select "Manage Alerts." Next click "Balance and Usage Notifications" and complete the fields for a "High Energy Usage Alert - Daily."

Fill in the dollar amount that will trigger a high-energymusage alert. Keep in mind this is a DAILY usage alert. So if your electric bills average \$180 a month, you may want to set your daily usage alert for \$6.00 (\$180 divided by 30 days = \$6.00). You may want to adjust the amount seasonally depending on your summer and winter energy consumption patterns.

You can receive the alerts via text or email. If you opt to receive alerts via text you will need to



Opt In when the initial enrollment notice is sent to your cell phone. Please do not skip that step.

If the process above sounds too complicated, you are welcome to call the co-op and have one of our service representatives complete enrollment for you.

However, I do hope you will become familiar with the member portal and take a deeper dive into your daily energy consumption to learn how it corresponds with outdoor temperatures and household activities.

Every member can access their daily energy consumption. Depending on the age of your meter you can also access either hourly or 15-minute interval readings. That data can be particularly meaningful if you want to determine how much different loads in your home contribute to your overall energy bill. You can even experiment with daily thermostat settings to better understand the correlation between the temperature setting and your energy consumption.

Take care and stay warm efficiently this winter.

DIRECTOR QUALIFICATIONS

The following guidelines are excerpted from Board Policy No. 302 and Bylaw 4.02 to ensure quality representation.

Legal & Personal Requirements

- A Tideland member & bonafide resident of the directorial district.
- 2. A member no less than 2 years on the date of election.
- 3. Willing to promote & protect the co-op's interests.
- 4. Able to impartially represent the entire co-op membership.

- 5. Willing to regularly attend board meetings.
- 6. May not be a close relative of an existing director or employee.
- 7. Is not employed by or financially interested in a competing enterprise.
- 8. Was not previously employed by TEMC, any other utility/energy company, or any entity which substantially rendered services to a utility/energy company.

Aspects of Service

- 1. Put forth the effort to understand the co-op and provide sound judgement to reach decisions.
- 2. Respect official decisions made by a majority of the board.
- 3. Objectively evaluate questions and problems facing TEMC.

Points to Consider

- 1. Has the member demonstrated sound business judgement?
- 2. Has the member shown a capacity for leadership & a reputation for honesty & integrity?
- 3. Has the member shown a capacity for working well with others?
- 4. What problems might hinder the nominee's success?

Simple solutions for winter savings



Remove window air-conditioning units

This will allow you to shut the window to keep heat in and the cold out. If removal is not an option, install an inexpensive shrink wrap window kit to cover the window in its entirety.



Get a flashlight and inspect your supply registers

This photo from a Tideland energy audit shows just how easily we discovered a disconnected duct. Fortunately, the solution was a zip tie and mastic paste. Inexpensive repair. Huge savings!



Close dampers when your fireplace is not in use

Beyond closing the damper, consider your overall energy strategy when using an open-hearth fireplace. Studies show a net 8% loss of your home's heat when in use due to combustion air exchanges.



Make sure all your crawlspace vents are closed

Your floors will be much warmer this winter and your pipes better protected with your crawlspace vents closed. Be sure your crawlspace access door is securely closed as well.



In winter, dry clothes during the warmest part of the day

All that hot air being dumped outside during the drying process requires makeup air inside your home. Where does that air come from? Outdoors. And it's unconditioned and unfiltered.



Are you sure all your windows are closed?

You would be shocked how often we find one or more windows open during energy audits. Most often the top sash isn't fully up. So take a look around. You may be surprised!



Keep interior doors and individual registers open

Shutting them in an attempt to redirect HVAC heat/air to another part of the house restricts efficient return air flow, increases energy costs and can damage the system.



Routinely replace/clean your HVAC filters

Once a month; every two weeks if remodeling. A basic filter is recommended unless your return air is sized for pleated media.



Sign up for levelized billing

Levelized billing provides you with a way to guard against large fluctuations in your monthly electric bills. Program participants pay a rolling average of their previous 12 months electric use. While you can expect fluctuations in the amount due every month, the changes are minimal. If your usage is trending up the levelized amount will increase. If usage trends down the levelized amount will decrease. Levelized billing helps members with month to month budgeting while at the same time alerting members to increased kilowatt-hour (kWh) consumption.

Levelized billing is a free service. Participants must keep their electric account current. Failure to pay by the due date will result in the loss of levelized billing privileges.
